I am very pleased to report that this year we have increased our investment in vital medical and other hospital equipment by more than 35%. The support of many businesses, individuals and groups has been integral to this achievement.

We also invested in supporting patients and their families, particularly through the support of our 100 strong volunteer network.

This year we have expanded our commercial activities with the opening of a Gift Shop to provide services to patients, visitors and staff at the Mackay Base Hospital. The gift shop is manned entirely by our dedicated and enthusiastic team of volunteers.

I would like to acknowledge the dedication of our staff and volunteers, led by General Manager, Ms Adrienne Burke.

I would also like to acknowledge the contribution Ms Antoinette Morton has made as Chairperson of the Mackay Hospital Foundation and to recognize the ongoing support of the MHHS Board, led by Mr Colin Meng, Chairperson.

This year we said farewell to Board Member Danielle Hornsby and we thank Danielle for her contribution to the Foundation since its establishment.

On behalf of the Mackay Hospital Foundation Board I thank you for your support and look forward to continuing to work with the community to achieve our objectives.

# ABOUT US

## ***Regulatory Framework***

The Mackay Hospital Foundation (the Foundation) was established on 15 October 2010 under the *Hospitals Foundations Act 1982*. The Foundation is endorsed as a deductible gift recipient according to Subdivision 30-BA of the *Income Tax Assessment Act 1997* as a charitable institution whose principal activity is to promote the prevention or control of disease in human beings.

## ***Our Role***

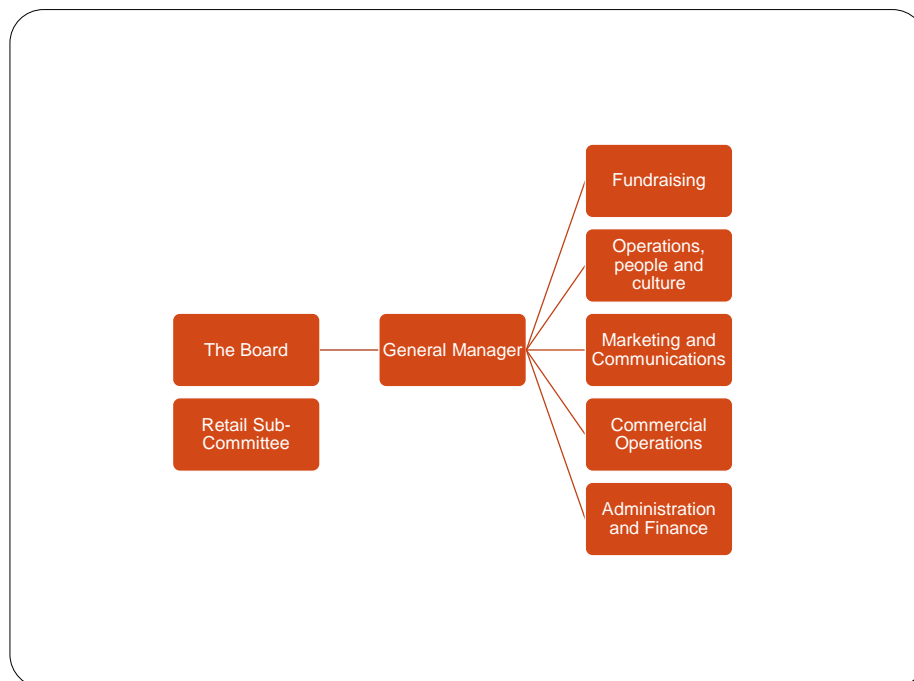
The Foundation is the principal fundraising body for the Mackay Base Hospital and other public hospitals and health services within the Mackay Hospital and Health Service, including Mackay, Proserpine, Sarina, Moranbah, Dysart, Middlemount, Clermont, Bowen and Collinsville.

Funds raised in support of our local hospitals are principally invested in medical and other hospital equipment.

As the fundraising body for public hospitals within the region, the Foundation works with individuals, community organisations and businesses to support our local hospitals.

## **Risk Management**

The Mackay Hospital Foundation manages risks to the Foundation achieving its objectives by identifying risks, their likelihood and their potential impact and preparing mitigation strategies for high risks. We have identified any high operational or financial risks through our previous annual financial audits and have implemented or amended processes and procedures accordingly.

## **Information Management Systems**

The Foundation has a records management system that incorporates electronic and paper records and complies with the requirements of the *Public Records Act 2002*. A retention and disposal system assists in ensuring our records are retained for the required period and to comply with Information Standard 40: Recordkeeping and Information Standard 31: Retention and disposal of public records.

## **Human Resources**

The Mackay Hospital Foundation team embodies the values of the Foundation and is committed to achieving our vision.

As at 30 June 2015, the Mackay Hospital Foundation employed 5.1 full time equivalent staff including 3.4 full time equivalent staff in the Café and Gift Shop and 1.7 full time equivalent staff in the office. The staff are supported by a dedicated team of volunteers.

Vacant positions have been advertised through an online recruitment website or local regional newspaper and merit-based recruitment and selection processes completed for each appointment. Upon appointment, new employees are provided with a thorough induction and orientation to become familiar with the Mackay Hospital Foundation, the workplace and their role.

To promote flexible working arrangements and support staff to have work-life balance, the Mackay Hospital Foundation considers all reasonable requests regarding flexible working arrangements. This encompasses requests such as changes to work patterns, compressed working weeks and amendment to start and finishing times.

## Code of Conduct

We recognise the ethical principles of integrity and impartiality, promoting the public good, commitment to the system of government and accountability and transparency, and associated ethics values outlined in the *Public Sector Ethics Act 1994* (the Act).



# Performance stories: *our achievements in 2014-2015*

## *Financial Performance*

### ***Income:***

In the past year, the Mackay Hospital Foundation met its statutory obligations as a hospital foundation established under the *Hospitals Foundations Act 1982*.

- Our revenue in 2014-15 of \$939,657 was mainly comprised of income from our business activities (69%) and income from donations and grants (29%) generously donated by the community.
- The 2014-2015 financial year has continued to be a challenging period for fundraising due to constrained economic conditions. Our total income is 9% lower than the previous year, due in part to a reduction in external grant funds received and a reduction in fundraising income. In this year our income from commissions increased by over 70% due in part to our expanded vending machine program at the Mackay Base Hospital and the licence fees for a new automatic teller machine service.
- In the past year we received donations and grants of more than \$270,000 in support of the Mackay Base Hospital and other public hospitals and health services within our region. In addition, we received in-kind donations of medical equipment from the Humpty Dumpty Foundation and Variety Queensland as a result of successful grant applications for medical equipment for both Proserpine Hospital and Mackay Base Hospital.
- We were fortunate to again benefit from the fundraising of hospital auxiliaries and received a donation from the Bowen Hospital Auxiliary for medical equipment for Bowen Hospital.
- In addition, regular fundraising activities including the Woolworths Annual Wall Token campaign, the Blue River Mackay Lion's Club Annual Charity Bash Golf Day, Sea FM Mackay and the Whitsundays' Give Me 5 for Kids campaign, the Myer Stores Community Fund and regular fundraising runs by the Mackay LRC Running Club and 80/20 Fitness contributed to donations income in the 2014-15 financial year. In 2014-15 we also were the charity of choice for the Kustom Inking for Charity fundraiser which raised over \$10,000 for our local hospitals.
- This year we received grants totaling \$15,000 from Glencore and Abbot Point Bulkports Pty Ltd which enabled purchase of an IVent ventilator for Bowen Hospital.
- We administered the second year of annual nursing awards, the Nurse Specialty Award and the McFadzen Award recognizing the achievements of nurses within the Mackay Hospital and Health Services.
- We were pleased to continue our partnerships with Mackay Sugar Limited and John Donnelly the Good Guys who each donated \$10,000 for the purchase of a new ultrasound machine for the Renal Unit of the Mackay Base Hospital.

- We continued our partnership with local company, Blue River Water, which displays our logo on their new range of 600ml bottled water and makes a donation to the Mackay Hospital Foundation for each bottle sold.
- This year we welcomed Nick's IGA choosing to support the Foundation with a monthly fundraising day in two Nick's IGA stores in Mackay.

### ***Expenditure:***

- In 2014-15 the Mackay Hospital Foundation's total expenses were \$1.04M. This includes \$283,037 in grant funding and \$426,038 in supplies and services, including business supplies, an increase of 3% on the previous year.
- Our grant funding to purchase medical and other equipment for our local hospitals increased by 36% in comparison to the previous year.
- We have invested in the following equipment to benefit the healthcare of patients in our community:
  - \$19,745 ultrasound for the Renal Unit of the Mackay Base Hospital;
  - \$14,063 vital signs monitors for the Medical Ward of the Mackay Base Hospital;
  - six recliner chairs valued at \$10,725 for the Child and Adolescent Unit of the Mackay Base Hospital;
  - \$2,420 Rad 5 pulse oximetre for Moranbah Hospital;
  - two recovery chairs valued at \$11,000 for the Day Procedure Unit, Mackay Base Hospital;
  - \$8,175 Gynecological procedure chair for Bowen Hospital;
  - \$7,202 BiliSoft equipment for Moranbah Hospital;
  - six breastfeeding recliner chairs valued at \$6,395 for Special Care Nursery, Mackay Base Hospital;
  - \$7,904 bariatric and day chairs at Moranbah Hospital;
  - \$1682 for a dressing trolley for Moranbah Hospital;
  - \$4,545 portable oxygen concentrator for Sarina Hospital;
  - \$4,066 height adjustable baby bath for Proserpine Hospital;
  - \$3,207 oxygen blender for Moranbah Hospital;
  - \$2,219 for a treatment table at BreastScreen Mackay; and
  - \$20,321 Ivent ventilator for Bowen Hospital.

### ***Overview***

In this year the Mackay Hospital Foundation continued to achieve its strategic objective of developing and diversifying its revenue base investing in the fit-out and establishment of a new Gift Shop, purchase of three snack vending machines and introduction of an automatic teller machine at the Mackay Base Hospital. The investment in these business activities in this financial year will enable the Foundation to generate income for future years.

This year our donations and grants income was 22% lower than the previous year. This was mainly due to reduction in project specific external grant funds received.

The annual financial statements for the Foundation for the 2014-15 financial year are included at the end of this Annual Report. The financial records of the Foundation were audited this year by Brown and Bird.

### ***Volunteering:***

- The Mackay Hospital Foundation coordinates a volunteer program at the Mackay Base Hospital providing a range of services to support patients, their families, visitors and hospital staff.
- Volunteers have provided invaluable support through the following services and areas: Play Group, Information Desk, Trolley Service, Community Rehabilitation Centre, General Surgical Unit, Fundraising Support, Gift Shop, Administration Support, Vending Machine program, Library Service, Café and other services.
- We thank our volunteers for their ongoing commitment to supporting their local hospital and hospital foundation. The longevity of volunteers' service at the Mackay Base Hospital is testament to their dedication. As at the end of this reporting period the Foundation coordinated a program of 110 volunteers.



### ***Commercial Opportunities:***

We have continued to provide our Mackay Hospital Foundation Café at the Mackay Base Hospital to provide services to visitors, staff and patients. This year we opened our Gift Shop at the Mackay Base Hospital, which provides a range of new services including locally produced giftware. This venture would not be possible without the support of our volunteers who provide a friendly, welcoming face to visitors.

We delivered our daily trolley service to patients and staff at the Mackay Base Hospital over 250 days of the year.

This year we expanded our vending machine service with the purchase of three snack vending machines which provide services to visitors, patients and staff, particularly after hours.

## **2015-2016: *the year ahead***

Our focus in 2015-2016 will continue to be promoting the Mackay Hospital Foundation as the charity of choice for our local community.

We will focus on growing our donations, fundraising and grants income streams through the introduction of new fundraising programs.

These areas of focus will be underpinned by strong governance and responsible management of our administration and finance, and satisfying all regulatory requirements.

These areas of focus will enable us to continue to work towards achieving our vision to contribute to quality public healthcare for people in the Mackay Isaac Whitsunday region, in partnership with our community.

### ***How we will measure our performance***

We will measure our performance by the number and value of donations received in 2015-16 and the number of grants issued by the Mackay Hospital Foundation to invest in innovative health services, medical and health technology, support services for patients and staff and education, training and research.

***Objectives and Principal Activities of the Mackay Hospital Foundation***

The objectives of the Mackay Hospital Foundation are to raise funds to support the pursuit of excellence in service and people's health outcomes at the Mackay Hospital and Health Service and to aid the Mackay Base Hospital and any of its services whether established or proposed and to aid any hospital or health service of the Mackay Hospital and Health Service.

The Mackay Hospital Foundation is funded for the services it delivers principally by donations, sponsorships and support from the community.

**1. *Summary of Significant Accounting Policies***

**(a) Statement of Compliance**

The Mackay Hospital Foundation has prepared these financial statements in compliance with section 42 of the *Financial and Performance Management Standard 2009*.

These financial statements are general purpose financial statements and have been prepared on an accrual basis in accordance with Australian Accounting Standards and Interpretations. In addition, the financial statements comply with Queensland Treasury's Minimum Reporting Requirements for the year ending 30 June 2015, and other authoritative pronouncements.

With respect to compliance with Australian Accounting Standards and Interpretations, the Mackay Hospital Foundation has applied those requirements applicable to not-for-profit entities, as the Mackay Hospital Foundation is a not-for-profit entity. Except where stated, the historical cost convention is used.

**(b) The Reporting Entity**

The financial statements include the value of all income, expenses, assets, liabilities and equity of the Mackay Hospital Foundation. There are no controlled entities.

The major services undertaken by the Mackay Hospital Foundation are disclosed at paragraph 'Objectives and Principal Activities of the Mackay Hospital Foundation'.

The consolidated financial statements include the value of all assets, liabilities, equity, revenues and expenses of the Mackay Hospital Foundation.

**(c) Grants and Contributions**

Grants, contributions, donations and gifts that are non-reciprocal in nature are recognised as revenue in the year in which the Mackay Hospital Foundation obtains control over them (control is generally obtained at the time of receipt). Where grants are received that are reciprocal in nature, revenue is progressively recognised as it is earned, according to the terms of the funding arrangements.

**(d) Cash and Cash Equivalents**

For the purpose of the Statement of Financial Position and Statement of Cash Flows, cash assets include all cash and cheques receipted but not banked at 30 June.

**(e) Receivables**

Trade debtors are recognised at the amounts due at the time of sale or service delivery i.e. the agreed purchase/contract price. Settlement of these amounts is required within 30 days from invoice date.

The collectability of receivables is assessed periodically with provision being made for impairment.

**(f) Inventories**

Inventories held for sale are valued at the lower of cost and net realisable value.

Net realizable value is determined on the basis of the Mackay Hospital Foundation's normal selling pattern.

Expenses associated with marketing, selling and distribution are deducted to determine net realisable value.

**(g) Payables**

Trade creditors are recognised upon receipt of the goods or services ordered and are measured at the nominal amount i.e. agreed purchase/contract price, gross of applicable trade and other discounts. Amounts owing are unsecured and are generally settled on 30 day terms.

**(h) Financial Instruments**

*Recognition*

Financial assets and financial liabilities are recognised in the Statement of Financial Position when the Mackay Hospital Foundation becomes party to the contractual provisions of the financial instrument.

*Classification*

Financial instruments are classified and measured as follows:

- Cash and cash equivalents – held at fair value through profit or loss
- Receivables – held at amortised cost
- Payables – held at amortised cost.

**(i) Employee Benefits**

Employer superannuation contributions, annual leave levies and long service levies are regarded as employee benefits.

Workers' compensation insurance is a consequence of employing employees, but is not counted in an employee's total remuneration package. This is not an employee benefit and is recognised separately as employee related expenses.

*Wages, Salaries and Sick Leave*

Wages and salaries due but unpaid at reporting date are recognised in the Statement of Financial Position at the current salary rates.

As the Mackay Hospital Foundation expects such liabilities to be wholly settled within 12 months of reporting date, the liabilities are recognised at undiscounted amounts.

Prior history indicates that on average, sick leave taken each reporting period is less than the entitlement accrued. This is expected to continue in future periods. Accordingly it is unlikely that existing accumulated entitlements will be used by employees and no liability for unused sick leave entitlements is recognised.

As sick leave is non-vesting, an expense is recognised for this leave as it is taken.

For unpaid entitlements, relating to PAYG and superannuation, expected to be paid within 12 months, the liabilities are recognised at their undiscounted values.

*Key Management Personnel and Remuneration*

Key management personnel and remuneration disclosures are made in accordance with section 5 of the Financial Reporting Requirements for Queensland Government Agencies issued by Queensland Treasury and Trade. Refer to Note 5 for the disclosure on key management personnel and remuneration.

**(j) Insurance**

The Mackay Hospital Foundation's non-current physical assets and other risks are insured. In addition, the Mackay Hospital Foundation pays premiums to WorkCover Queensland in respect of its obligations for employee compensation.

**(k) Taxation**

The Mackay Hospital Foundation is endorsed by the Australian Taxation Office as a health promotion charity and is endorsed to access the following tax concessions from the dates shown:

Income tax exemption from 1 December 2010 under Subdivision 50-B of the *Income Tax Assessment Act 1997*.

GST concessions from 1 December 2010 under Division 176 of *A New Tax System (Goods and Services Tax) Act 1999*.

FBT exemption from 1 December 2010 under section 123D of the *Fringe Benefits Tax Assessment Act 1986*.

FBT and GST are the only taxes accounted for by the Mackay Hospital Foundation. GST credits receivable from and GST payable to the ATO are recognised.

**(l) Issuance of Financial Statements**

The financial statements are authorized for issue by the Deputy Chairperson and General Manager at the date of signing the Management Certificate.

**(m) Accounting Estimates and Judgments**

The preparation of financial statements necessarily requires the determination and use of certain critical accounting estimates, assumptions and management judgments that have the potential to cause a material adjustment to the carrying amounts of assets and liabilities for the next financial year. Such estimates, judgments and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in future periods as relevant.

**(n) Comparatives**

Amounts included in the financial statements are in Australian dollars.

**(o) New and Revised Accounting Standards**

The Mackay Hospital Foundation did not voluntarily changes any of its accounting policies during 2014-2015.

A revised version of Australian Accounting Standard AASB 119 *Employee Benefits* became effective for reporting periods beginning on or after 1 January 2013. The only implications for the Mackay Hospital Foundation were the revised concept of 'termination benefits' and the revised recognition criteria for termination benefit liabilities. If termination benefits meet the AASB 119 timeframe criterion for 'short-term employee benefits', they will be measured according to the AASB 119 requirements for 'short-term employee benefits'. Otherwise, termination benefits need to be measured according to the AASB 119 requirements for 'other long-term employee benefits'.

All other Australian accounting standards and interpretations with future commencement dates are either not applicable to the Mackay Hospital Foundation's activities, or have no material impact on the entity.
